## SHARK DIVE XTREME DECLARATION

This form is to be completed by all participants of the Shark Dive Xtreme experience before commencement and includes all activities at SEA LIFE Sydney Aquarium.

### Participant Declaration:

By signing this document below, I honestly declare that:

1. I am over 14 years of age.
2. I have completed the medical declaration honestly.
3. I am not under the influence of drugs, legal or illegal, including alcohol.
4. I will obey and follow the instructions of SEA LIFE Sydney team members, and not interfere with the SEA LIFE Sydney team member's ability to conduct the experience in a secure and safe manner. I will not attempt to touch any animals or damage or deface any part of the Shark Dive Xtreme experience or equipment. I understand that I may be removed from the experience, without refund, if I do not comply with these terms.

### I understand that:

1. Snorkeling / scuba diving is a potentially dangerous activity and that I have attended and understood a dive briefing entailing the potential dangers involved. I have also had the opportunity to personally discuss with the dive leader the potential dangers of snorkeling or scuba diving and the Shark Dive Xtreme experience. I have been briefed and understand the following but not limited to key points:

SEA LIFE Sydney will not (to the extent permissible by law) be responsible for any loss, damage or injury arising from or connected with the Shark Dive Xtreme experience no matter how that loss, damage or injury is caused, including if caused by any medical condition, physical or psychological. If I do not follow instructions given to me by SEA LIFE Sydney and as a result of disobeying those instructions, I suffer loss, damage or injury; I will not hold Sydney Sea Life Aquarium liable. SEA LIFE Sydney specifically excludes liability for loss or damage arising from any negligent act or omission of SEA LIFE Sydney or employee, agent or contractor of SEA LIFE Sydney.
  3. I hereby release, discharge and waive any rights I may have to claim against, Sydney Sea Life Aquarium, its related bodies corporate and their employees and agents, to the extent permitted by law, from all claims which I now or at any time have in connection with or incident to my participation in Shark Dive Xtreme or the circumstances stated in this declaration. I agree that this includes any claims which I could or might have if it was not for this declaration.
